Increasing Access to Safe Disposal

Providing a safe way to dispose of unwanted or unused medications locally reduces the likelihood of misuse or diversion. We're providing secure disposal options close to home.

Encouraging Appropriate Utilization

Limiting the amount of opioids available in the community can help reduce the potential for abuse. We've implemented criteria to help CVS Caremark® clients manage opioid utilization in a manner consistent with the Centers for Disease Control Guideline.

Expanding Access to Life-Saving Antidotes

The opioid overdose-reversal drug, naloxone, is key to addressing opioid abuse locally. We're implementing an industry-leading program to increase access to naloxone.



Life-saving naloxone is available in **48 states**

to patients at CVS Pharmacy locations, without an individual prescription

9,800 CVS Pharmacy locations

have in-store signage and in-store radio messages to educate patients about the availability and accessibility of naloxone

Educating Patients and Communities
